COLOUR

Due to the restrictions and constraints of textile printing, we can only use 'uncoated' ink, therefore your pantone reference will need to be a 'u' code. If you are expecting coated ink ('c' code) please double check the pantone colour against an uncoated pantone book before approving the artwork as coated ink will differ in colour to uncoated ink and has a glossy finish as oppose to matt. Also the colour and texture of a product can have an effect on the final print colour.

Please note: We cannot be held responsible if the colour is not as expected for the above reasons.

PRINT ALIGNMENT

We print to a 5mm tolerance. This is to allow for discrepancies in product production and manual positioning of our products within the print process.
