1. Tests T.1 to T.5 shall be conducted in sequence on the same battery. Tests T.6 and T.8 shall be conducted using not otherwise tested cells. Test T.7 may be conducted using undamaged batteries previously used in Tests T.1 to T.5 for purposes of testing on cycled batteries.




Figure 1 Top view of Cell




Figure 2 Bottom view of Cell
