(a) All offers to supply products from stock are subject to the products being available at the time of receipt by the Company of the Buyer's order.

- ## 5. TERMS OF PAYMENT

(a) Subject to the following provisions of this Condition unless otherwise agreed in writing, the price will be due and payable by the Buyer for the price of the Product on or at any time after the date on which the Product has been notified by the Company to the Buyer as being ready for collection or dispatch (in the case of sales ~~works~~) whether notification has been made verbally or in writing or by electronic means, unless the Buyer fails or refuses to take delivery of the Product, in which case the Company shall be entitled to invoice the Buyer for the price at any time after the Buyer has been notified that the Product is ready for collection, or the Company has tendered delivery of the Product
