Interpretation

'CONDITIONS' means the standard terms and conditions of sale set out in this document and (unless the context otherwise ~~includes~~ ~~includes~~ any special terms and conditions agreed in writing between the Buyer and the Seller.

'CONTRACT' means the contract for the purchase and sale of the goods.

Risk and Property

Risk of damage to or loss of the Goods shall pass to the Buyer.

Impact of any regulations or embargoes;
