## COMPLIANCE REQUIREMENTS

- **Triman.** Please ensure that the Triman logo and appropriate info-tri pictograms with abbreviation FR are noted on the product/product packaging/leaflet for these EPR product categories: All packaging, Print paper & graphics paper, Furniture, Textiles, Household linen and footwear, Electric and electronic equipment, Batteries, Accumulators, Toys, Games and Tools.
- **General Product Safety Regulation (GPSR).** All products must feature Brand Addition EU postal address, (**Brand Addition GmbH, Europastrasse 19a, 45888 Gelsenkirchen, Germany**), Brand Addition electronic (web) address, (**www.brandaddition.com/contact**), PO number & Brand Addition SKU number.
- **UKCA/CE.** All electrical/electronic products/toys/PPE must be CE/UKCA marked indelibly with a minimum of 5mm in height. Where size of product is restrictive the marking is permitted on the packaging or instruction label. If a product notes a CE marking, please ensure that the UKCA mark is added alongside
- **Waste of electrical and electronic equipment (WEEE).** The WEEE wheelie bin symbol marking must appear on any electrical and electronic equipment placed on the EU and UK market.
- **European Union Deforestation Regulation (EUDR).** All products impacted by EUDR must be compliant with the regulation, and a due diligence statement must be produced and sent. Alternatively, the item must be 100% recycled.

**The supplier also agrees to ensure that the following requirements are met:**

- **Country or origin.** We cannot accept batches of a product with a mixed country of origin. Please ensure that each product has a single origin, otherwise the delivery will be rejected upon inspection. If the origin of the product is different to the origin noted in our PO, you must inform your Brand Addition contact.
- Please ensure that all clothing or textiles are individually polybagged. A product code, description and size (if applicable) will need to be clearly visible on the outside of the polybag (either printed, or on a sticker).

- All compliance requirements and guidance (product category specific) are accessible via the hyperlinks noted underneath each product on the PO. Please refer to the material on the documents to ensure that the order is fully compliant.

## WAREHOUSE REQUIREMENTS

The supplier must conform to the below requirements. **Any non-conformance will result in the order being turned away or rejected, and the supplier will be responsible for arranging collection at their cost.**

- A delivery note must accompany all deliveries, containing the BA purchase order number, BA stock code, BA product description, carton quantity, pallet quantity (if palletised) and product batch number (your reference).
- All cartons must be labelled to show BA product code & description, PO number, carton quantity and carton number (1 of....., 2 of..... etc), pallet quantity and pallet number, (if palletised).
- No mixed SKU's, or mixed garment sizes per carton are permitted. Cartons containing multiple sizes and/or SKU's will be rejected at the point of delivery.
- All deliveries of 1 pallet or more must be pre-booked. Carton numbers of 20 or more will need to be palletised and will need to be pre-booked. Deliveries below 20 cartons do not need to be pre-booked.
- Brand Addition Ltd (Manchester warehouse) will accept Standard UK pallets & standard Euro pallets. Brand Addition GmbH (Gelsenkirchen warehouse) will only accept standard Euro pallets
- The maximum pallet height for bulk materials (1 SKU per pallet) allowed is 140cm. The maximum pallet height for mixed materials (multi SKU per pallet) allowed is 180cm. The pallet maximum load should be strong enough to carry the weight of goods.
