- Please ensure all communications in relation to artworks and order status are sent to your Innovation 1st contact as well as copying the e-mail address PurchaseOrders@innovation1st.com.
- · Suppliers should use plain boxes without any of their own branding.

- · SKU's must be boxed in their own cartons, we will not accept mixed SKU cartons.
- Boxes should be labelled with the following information in order to be accepted into our warehouse:
 - Innovation 1st SKU codes for the product being ordered
 - The quantity of items included in each box
 - Each carton must be barcoded with the barcode provided, it must be placed on each outer carton or if each outer carton has mixed SKUs then every inner carton. It is not necessary to barcode each individual product. There are two ways to create the barcode:
 - It can be copied straight from the PO provided
 - The SKU provided can be entered into a barcode software using the code 128 format, this will produce the barcode.
 - ALL orders that have not been barcoded as specified will result in the deliveries being rejected and returned to the sender.
- The following must be communicated to Innovation 1st as soon as possible:
 - Unders / overs must be communicated to Innovation 1st
 - Innovation 1st must be notified when orders are despatched.
 - The supplier should inform Innovation 1st about packaging details for the order, such as the number of boxes being delivered, dimensions, and weights, as soon as these are known by the supplier.
 - If there is any change to the agreed delivery date, the supplier should immediately raise this to their Innovation 1st contact.
- Deliveries should only be made to the stated delivery address on a business day, and between the hours of 9am -5pm.
- If wooden pallets are used for delivery of goods, all pallets must be certified and stamped legibly with International Plant Protection Certification (IPPC) logo.
