For containerised consignments a delivery time may be requested at the time of booking in. This is to ensure smooth turnaround of any delivering driver. Should a time slot not be agreed and/or requested, the driver will be unloaded at the earliest site availability schedule.

If a delivery booking has been made, and this schedule cannot be met, the supplier or freight agent or haulier must re-book and advise reason for the delay. For all other material delays, please contact your initial purchaser.

Documentation

There may be further documents that are not within the Brand Addition Logistic Procedures scope. These will be requested by Brand Addition prior to entering into any transaction.

Brand Addition Limited (Manchester Warehouse) accept the below pallet types.

Standard UK – 1200mm x 1000mm, 4 way entry, bottom stringer boards running around all four sides – <u>Preferred.</u>

Standard Euro Pallet - 800mm x 1200mm, 4 way entry, bottom stringer boards running in the 1200mm direction.

Pallet heights and weights

- The maximum pallet height for bulk materials (1 SKU per pallet) allowed is 140cm.
- The maximum pallet height for mixed materials (multi SKU per pallet) allowed is 180cm.
- The pallet maximum load should be strong enough to carry the weight of goods.

Pallet General

- Double stacking of pallets is *not* allowed. Brand Addition warehouses (including its 3PL partners) will not unload if pallets breach this requirement.
- Loads must be securely strapped to the pallet using stretch wrap or suitable alternative. Loads *must* be stable. If we have reason to feel that a load is unstable, we will reject the delivery.
- Goods must not be overhanging the pallet.
- Any pallet having multiple SKU's must be labelled "MIXED".

Should packaging not conform, Brand Addition reserves the right to reject the goods. Where repacking is required due to inadequate or damaged packaging, Brand Addition reserves the right to charge GBP30.00 per hour per person labour plus materials.
